# **Sample Preparation**

# Water Sample Ultrasonication

Samples were received and immediately frozen for later preparation. After thawing, the samples were inverted for 60 seconds to mix and sonicated to lyse cells and release of toxins.

# Solid Phase Extraction (SPE)

Preconditioned Strata X Polymeric SPE (200 mg) was loaded with 5 mL of sample, rinsed with 5% MeOH and eluted with 90% acetonitrile. Elutions were blown to dryness (N<sub>2</sub> at 60°C) and reconstituted in 5% MeOH/Deionized water (0.5 mL) providing a 10x preconcentration.

# **Analytical Techniques**

#### NOD

The method described in Foss and Aubel (2015) was modified to accommodate only nodularin. A Certified Reference Standard of NOD (1.0 ng/mL) was used to calibrate the method. Table 2 below shows the transitions monitored. A MDL was determined through standard addition (LFSM).
