Analytes: Nodularin (NOD)

Sample Preparation

Water Sample Ultrasonication

Samples were received and immediately frozen for later preparation. After thawing, the samples were inverted for 60 seconds to mix and sonicated to lyse cells and release of toxins. The FB1 sample was diluted 1:10 prior to solid phase extraction.

Solid Phase Extraction (SPE)

Preconditioned Strata X Polymeric SPE (100 mg) columns were loaded with 1 mL of sample, rinsed with 5% MeOH and eluted with 90% acetonitrile. Elutions were blown to dryness (N_2 at 60°C) and reconstituted in 5% MeOH/Deionized water (1.0 mL).

The method described in Foss and Aubel (2015) was modified to accommodate only nodularin. A Certified Reference Standard of NOD (1.0 ng/mL) was used to calibrate the method. Table 2 below shows the transition monitored. A MDL was determined through standard addition (LFSM).
